LA Department of Wildlife and Fisheries, Law Enforcement Division and the New Orleans Fire Department supported the USCG National On-Water Standards Validation Project for human-propelled recreational craft hosted by the New Orleans Yacht Club May 1-3, 2015.

A team of boating experts participated in a two and a half day program to confirm On-Water skills for paddling/ rowing that educators can build into on-the-water boating programs across the country. "The validation process provides a phenomenal opportunity for the boating community to not just comment, but actively participate 'out on the water' to help develop the national Standard," said Ed Huntsman, USCG's 8th District Recreational Boating Program Manager, following the completion of the New Orleans HUMAN-Propelled Test.

Throughout the weekend, 12 community volunteers participated in 2-hour test sessions. They were asked to operate their craft through a series of beginner level maneuvers. Eight paddle/rowing experts observed the operation of the craft to determine whether the National Standard being developed effectively reflects beginner-level HUMAN-propelled craft operation.

The National Recreational Boating Safety Program is administered by the USCG with funds derived from the Sport Fish Restoration and Boating Trust Fund to ensure "safe, secure, and enjoyable recreational boating experience..."

The Fund provides for grants administered by the USCG to states participating in the State Recreational Boating Safety Program. Louisiana is a participant of this program.

By complementing and deriving our goals from the National RBS Plan, Louisiana is not only working to make our waters safer, but the nations waters safer.
